The following is a quick reference guide to decisions requiring an absolute majority, under the *Local Government Act 1995* (LGA), associated regulations, and certain other legislation. Officers should refer to the relevant section for full details of each decision. In relation to Council, an 'absolute majority' means more than 50% of the number of positions on Council, whether vacant or not (LGA s.1.4).
